General Tour Information

What's Included

Transportation: All ground transport (except to and from airport, unless noted) during trip.

Accommodations: All hotels and all with private baths.

Meals: Breakfast daily. Lunch and dinners as noted on itineraries. Included group lunches and group dinners come with water, wine, coffee and occasionally digestives, unless otherwise noted.

Tastings, tours and classes: As listed on itinerary.

Entrance fees: To sites or museums, as listed on itinerary.

Tips: All restaurant tips for group meals, bus driver tip, and others as noted on itinerary.

Tour Guide: There will be an experienced tour guide with you throughout the trip.

What's Not Included

Airfare (We strongly recommend purchasing fully refundable or changeable tickets.)

Transportation to and from airport upon arrival and departure, unless noted on itinerary.

Personal Expenses: Snacks and beverages between meals, phone calls, laundry, minibars, internet access, room service, trip cancellation insurance, health insurance or needs, etc.

Extra alcoholic beverages during meals: Drinks or wine other than host-ordered can be ordered separately by you and put on your own tab.

Tips for service providers like tour guides, bellmen, and others unless noted on itinerary.

Travel Arrangements

We are happy to provide you with advice and/or suggestions for transportation from the airport to the first meeting place and from our last stop to your departing airport. We will, whenever possible, negotiate special rates for your first night's accommodations if it is at the same location we are using for the first night of the tour. We are also happy to help you with plans for extending your visit beyond the tour.

Insurance

We strongly recommend that you purchase trip cancellation and emergency medical insurances. No one books a trip with the intention of cancelling it, but unexpected events do occur. It is your responsibility to read and understand our cancellation policies. Exceptions cannot be made for any reason, including weather, injury/illness, or personal emergencies. We are unable to issue refunds or credits for failure to attend or failure to complete the retreat, or for arriving late or leaving early.

We represent **Travellex** Travel Insurance, and we can quote and issue a travel policy for you, but you are free to use any travel insurance company. You may also use this [link](#) to get a quote and/or book your own policy. We are happy to send you insurance brochures via email. We know that insurance can be expensive, but it is a fraction of the total cost of your entire trip, which may be worth it for you. The trip cancellation policies come with medical coverage.

We also ask that you carefully review your medical insurance to determine whether you are adequately covered for any eventuality while traveling in foreign countries. Purchasing additional traveler's health insurance, including medical evacuation coverage, is highly recommended. Please do your research as there are many different types of coverage and you may already have some limited coverages from your credit cards or health insurance. If you are not purchasing a trip cancellation policy that comes with medical coverage, then you can purchase a stand-alone medical policy from Travelex.

Your Responsibilities

While Moretti Wine & Food Travel trips are not active adventures, there is still some walking involved within the cities, at wineries, seeing sights, etc. We ask that you be in good physical condition, be able to keep up with a group and be able to walk at least a mile at a time without stopping.

Please take the time to review our pre-trip information (which you will receive at least 30 days prior to the start of the trip) so that you know what to expect in terms of weather, social etiquette, what to pack, etc... for your specific trip. If you have any pre-existing physical, mental or emotional disability that may require attention or treatments, you must report them, in writing, to us prior to the beginning of the tour along with any food allergies.

All participants must sign the Participant Release and Waiver of Liability at the end of this document.

Clients are required to act with respect and responsibility toward other guests, trip personnel, winery personnel, restaurant and hotel personnel and property at all times. We reserve the right to require an individual to withdraw from a tour, or to limit the amount of alcohol any guest may consume, without claims or complaints against us. If asked to withdraw from a trip, the traveler shall bear the costs associated with the plan changes. Should a traveler decide for any reason not to participate in certain parts of the Tour or not use certain goods/services included in the Tour, no refunds will be made for those unused parts, goods, or services of the Tour.

Any expenses caused by delays or events beyond our control shall be borne by the participant.

Reservations, Deposits and Payments

Your Registration Form contains our deposit and payment details. The tour deposit is required to confirm your booking and is refundable for 30 days following receipt. After that, it is **non-refundable**. Upon receipt of the deposit, we will send your invoice showing the deposit paid. Final payment date will be listed on the invoice. If a reservation is made less than 120 days prior to Tour commencement, payment must be made in full to secure confirmation. Should payment not be received in full by the due date, Traveler booking will be cancelled, and all deposits forfeited.

Cancellations and Refunds

Moretti Wine & Food Travel strictly adheres to its cancellation policy and cannot make exceptions.

Your deposit is fully refundable for 30 days from receipt. After that it is non-refundable.

The balance of the trip cost is due 120 days before the start of the program.

0-119 days before the start of the trip cancellation fee is 100% of the total price.

We do our best to refill vacated spots, and if we are successful, we will refund your trip moneys, less a \$500 administration fee, after the start of the trip.

All cancellations must be made in writing to: info@morettiwinetravel.com.

Again, we strongly recommend travel insurance that includes trip cancellation coverage to protect against financial loss due to unforeseen cancellations and other trip interruptions.

Moretti Wine & Food Travel reserves the right to cancel any trip for any reason at any time. In such a case, we will notify you as soon as that decision is made and offer you a full refund of all deposits and payments which will constitute a full settlement.

In regard to potential epidemics or pandemics, we may cancel the trip if we deem the situation to be potentially dangerous, or if we deem that restrictions at the destination will negatively impact the experience or the planned activities of the tour. Also in such a case, we will notify you as soon as that decision is made and offer you a full refund of all deposits and payments which will constitute a full settlement. Or we may reschedule the trip for a future date and offer to keep any deposits or payments to hold your place.

Trip Changes

Moretti Wine & Food Travel reserves the right to change itineraries as necessary. While we try to keep changes to a minimum, unforeseen circumstances (for example weather, strikes, acts of God, dangers, etc...) can happen. We will always keep the comfort and safety of our participants in mind and will make changes, as necessary, to protect our clients.

Tour Guides

We reserve the right to change tour guides as needed.

Participant Release and Waiver of Liability

This Participant Release and Waiver of Liability ("Agreement") is made and entered into effective as of (today's date)_____, by and between _____ ("Participant") and Moretti-Bloom Enterprises d/b/a Moretti Wine & Food Travel ("Operator"). Moretti Wine & Food Travel is a California Seller of Travel operating wine and food tours. As with all travel, there is always an element of risk present. Moretti Wine & Food Travel offers its travel program to Participant in exchange for the promises and covenants contained herein.

1. **Illness or Injury:** Participant understands the risk that they may be exposed to or infected by viruses or other diseases by participating in the travel program, and that such exposure or infection may result in personal injury, illness, disability and death. Participant further understands that the risk of exposure may result from the actions or omissions of Participant and others, including Operator, its owners, agents and representatives, businesses providing services to Moretti Wine & Food Travel's participants, fellow participants and all other persons present at or in proximity to the activities sponsored by Operator.
2. **Assumption of Risk:** Participant agrees to assume all of the risks associated with the activities sponsored by Operator and accepts sole responsibility for any injury to their person or property, including personal injury, illness, disability, death, property theft and property damage. Participant accepts sole responsibility for any and all liability, claims, demands, actions, damages, losses, costs and expenses, of every kind, directly or indirectly arising out of or relating to any injury to their person or property ("Claims").
3. **Release of Liability:** Participant hereby releases, waives and discharges Operator, its owners, agents and representatives, of and from the Claims. Participant understands that this release includes any claims based on the actions or omissions of Operator, its owners, agents and representatives. While we do our best to provide you with up-to-date information, we are not responsible for any diseases contracted during travel, or costs related to them.
4. **Indemnification:** Participant agrees to indemnify, defend and hold harmless Operator, its owners, agents and representatives, from and against the Claims. Participant understands that this indemnification includes any claims based on the actions or omissions of Operator, its owners, agents and representatives. Participant further agrees to indemnify, defend and hold harmless Operator, its owners, agents and representatives, from and against any claims by third parties based on the actions or omissions of Participant during the trip.
5. **Responsibility of Third Parties:** Moretti Wine & Food Travel, its owners, agents and representatives, accept no responsibility whatsoever in connection with the operation, safety, condition, service or failure to adhere to a published schedule of any aircraft, motor vehicle, boat, other conveyance, hotel, inn, winery, restaurant or other business providing services to Moretti Wine & Food Travel's participants.
6. **Trip Changes:** Moretti Wine & Food Travel reserves the right, either prior to or during the trip, in its good faith discretion, to change or reprice any tour as necessary. While we try to keep changes to a minimum, unforeseen circumstances (e.g., weather, strikes, acts of God, dangers, etc.) can occur. Changes may include, but are not limited to, the right of Operator to alter or omit any point in the itinerary, to substitute hotels, restaurants, activities, leaders, or to change any means of transportation without notice and without allowance for a refund, with liability for increased costs – if any – to be borne by Participant.
7. **General Information:** Participant represents that they have fully read and understood the "General Information" given to them, stating what is included and not included, information on travel arrangements, insurance recommendations, your responsibilities, reservations and deposits, cancellations and refunds, trip changes and other information.

8. Photographic Record: Participant agrees that any photographs, film or video taken of them while participating in a Moretti Wine & Food Travel trip may be freely used for promotional and commercial purposes.
9. Acknowledgment of Full Understanding: Participant represents that they have fully read, understood and voluntarily entered into this Agreement. Participant is sufficiently informed of the risks involved in participating in the travel program. Participant has had the opportunity to ask questions and consult with an attorney before executing this Agreement. Participant acknowledges that Moretti Wine & Food Tours, in requesting and receiving this Agreement, has relied upon the same in allowing my participation in its travel program. This Agreement applies to any and all trips, including those rescheduled from their original date. This Agreement shall be construed broadly to provide a release and waiver to the maximum extent permissible under applicable law.
